

### **TERMS AND CONDITIONS**

#### **BACKGROUND:**

This agreement applies as between you, the User of this Website or Purchaser and Lean Enterprise Academy Limited, the owner(s) of this Website. Your agreement to comply with and be bound by these Terms and Conditions is deemed to occur upon your first use of the Website. If you do not agree to be bound by these Terms and Conditions, you should stop using the Website immediately.

No part of this Website is intended to constitute a contractual offer capable of acceptance. The Purchaser's order constitutes a contractual offer and our acceptance of that offer is deemed to occur upon our sending a dispatch email to the Purchaser indicating that the order has been fulfilled and has been dispatched.

## 1. Definitions and Interpretation

In this Agreement the following terms shall have the following meanings:

"Account"	means collectively the personal information, Payment Information and credentials used by Users to access Paid Content and / or any communications System on the Website;
"Carrier"	means any third party responsible for transporting purchased Goods from our Premises to customers;
"Content"	means any text, graphics, images, audio, video, software, data compilations and any other form of information capable of being stored in a computer that appears on or forms part of this Website;
"Goods"	means any products that Lean Enterprise Academy Limited advertises and / or makes available for sale through this Website;
"Lean Enterprise Academy Limited"	means Lean Enterprise Academy Limited, The Old Vicarage, Goodrich, Ross-on-Wye, Herefordshire, HR9 6JE, UK;

"Service" means collectively any online facilities, tools, services or information that Lean Enterprise Academy Limited makes available through the

Website either now or in the future;

"Payment Information" means any details required for the purchase of Goods from this

Website. This includes, but is not limited to, credit / debit card

numbers, bank account numbers and sort codes:

"Purchaser" means any person or business that buys Goods from Lean Enterprise

Academy Limited from this Website;

"Purchase means collectively any orders, invoices, dispatch notes, receipts or

**Information**" similar that may be in hard copy or electronic form;

"Premises" Means our place(s) of business located at The Old Vicarage,

Goodrich, Ross-on-Wye, Herefordshire, HR9 6JE, UK;



"System" means any online communications infrastructure that Lean Enterprise

Academy Limited makes available through the Website either now or in the future. This includes, but is not limited to, web-based email,

message boards, live chat facilities and email links;

"User" / "Users" means any third party that accesses the Website and is not employed

by Lean Enterprise Academy Limited and acting in the course of their

employment; and

"Website" means the website that you are currently using (www.leanuk.org)

and any sub-domains of this site unless expressly excluded by their

own terms and conditions.

#### 2. International Customers

If Goods are being ordered from outside Lean Enterprise Academy Limited's country of residence, import duties and taxes may be incurred once the Goods reach their destination. Lean Enterprise Academy Limited is not responsible for these charges and we undertake to make no calculations or estimates in this regard. If a Purchaser buying internationally, they are advised to contact their local customs authorities for further details on costs and procedures. The Purchaser of the Goods will also be the importer of record and as such should ensure that the purchase is in full compliance with the laws of the country into which the Goods are being imported. Please be aware that Goods may be inspected on arrival at port for customs purposes and Lean Enterprise Academy Limited gives no guarantee that the packaging of the Goods will be free of signs of tampering.

#### 9. Accounts

- 9.1 In order to purchase Goods on this Website and to use the enquiry facilities Users are required to create an Account which will contain certain personal details and Payment Information which may vary based upon a User's use of the Website as we may not require payment information until a purchase is to be made. By continuing to use this Website you represent and warrant that:
  - 9.1.1 all information you submit is accurate and truthful;



- 9.1.2 if you are buying on behalf of your employers, you have the authority to submit Payment Information where any such authority is required; and
- 9.1.3 you will keep this information accurate and up-to-date.

Your creation of an Account is further affirmation of your representation and warranty.

- 9.2 It is recommended that you do not share your Account details, particularly your username and password. Lean Enterprise Academy Limited accepts no liability for any losses or damages incurred as a result of your Account details being shared by you. If you use a shared computer, it is recommended that you do not save your Account details in your internet browser.
- 9.3 If you have reason to believe that your Account details have been obtained by another without consent, you should contact Lean Enterprise Academy Limited immediately to suspend your Account and cancel any unauthorised purchases that may be pending. Please be aware that purchases can only be cancelled until they are dispatched. In the event that an unauthorised purchase is dispatched prior to your notifying us of the unauthorised nature of the purchase, Lean Enterprise Academy Limited accepts no liability or responsibility and you should make contact with the Carrier detailed in the Purchase Information.
- 9.4 When choosing a username Users are required to adhere to the terms set out above in Clause 8. Any failure to do so could result in the suspension and/or deletion of your Account.

### 10. Termination and Cancellation

- 10.1 Either Lean Enterprise Academy Limited or a User may terminate an Account. If Lean Enterprise Academy Limited terminates your Account, you will be notified by email and an explanation for the termination will be provided. Notwithstanding the foregoing, we reserve the right to terminate without giving reasons.
- 10.2 If Lean Enterprise Academy Limited terminates an Account, any current or pending purchases on your Account will be cancelled and will not be dispatched.
- 10.3 Lean Enterprise Academy Limited reserves the right to cancel purchases without stating reasons, for any reason prior to processing payment and dispatch.
- 10.4 If purchases are cancelled for any reason prior to dispatch Purchasers will be refunded any monies paid in relation to those purchases.
- 10.5 If a User terminates their Account any non-dispatched purchases will be cancelled and a full refund of any monies paid in relation to those purchases will be paid through the payment method used when the Goods were purchased.

# 11. Payment

11.1 Any and all invoices are due for payment on the date shown on the invoice, unless alternative arrangements have been agreed between the Purchaser and Lean Enterprise Academy Limited.

## 12. Goods, Pricing and Availability

12.1 Whilst every effort has been made to ensure that all graphical representations and descriptions of Goods available from Lean Enterprise Academy Limited correspond to the actual Goods, Lean Enterprise Academy Limited is not responsible for any variations from these descriptions. This does not exclude our liability for mistakes due to negligence on our part and refers only to variations of the correct Goods, not different Goods altogether.



Please refer to Clause 15.1 for incorrect Goods.

- 12.2 Lean Enterprise Academy Limited does not represent or warrant that such Goods will be available. Stock indications are not provided on the Website.
- 12.3 All pricing information on the Website is correct at the time of going online. Lean Enterprise Academy Limited reserves the right to change prices and alter or remove any special offers from time to time and as necessary.
- 12.4 In the event that prices are changed during the period between an order being placed for Goods and Lean Enterprise Academy Limited processing that order and taking payment, you will be contacted prior to your order being processed with details of the new price;
- 12.5 All prices on the Website do not include VAT. Lean Enterprise Academy Limited's VAT number is GB815606143.

## 13. Property, Risk and Account of Profits

- 13.1 Title in Goods will not pass to the Purchaser until the full purchase price for those Goods has been received by Lean Enterprise Academy Limited. Title remains with Lean Enterprise Academy Limited until payment is complete.
- 13.2 If the Purchaser sells the Goods on to its own customers in any form, either as purchased from Lean Enterprise Academy Limited or forming a component part of a larger Good, and any amount of the purchase price payable to Lean Enterprise Academy Limited remains outstanding, the Purchaser must account to Lean Enterprise Academy Limited for the proceeds of such a sale. The Purchaser is then required to hold such proceeds on trust for Lean Enterprise Academy Limited until payment has been received in full by Lean Enterprise Academy Limited.
- 13.3 Lean Enterprise Academy Limited reserves the right to trace all proceeds under the principles of Re Hallett's Estate (1880) 13 Ch D 696. Once the payment date has passed, if any sums remain outstanding, Lean Enterprise Academy Limited has the right to enter the Purchaser's premises and remove any Goods which, by virtue of sub-Clause 13.1, remain the property of Lean Enterprise Academy Limited.

### 14. **Delivery**

- 14.1 Lean Enterprise Academy Limited will notify you by way of email when your goods are to be dispatched to you. The message will contain details of any reasons for a delay in the delivery of the Goods purchased by you.
- 14.2 If Lean Enterprise Academy Limited receives no communication from you, within 5 days of delivery, regarding any problems with the Goods, you are deemed to have received the Goods in full working order and with no problems.

## 15. Returns Policy

Lean Enterprise Academy Limited aims to always provide high quality Goods that are fault free and undamaged. On occasion however, goods may need to be returned. Returns are governed by these Terms and Conditions.

15.1 If the Purchaser receives Goods which do not match those ordered, unless accompanied by an explanatory note detailing the changes, stating reasons for the changes and setting out your options, the Purchaser should contact us within 10 working days to arrange collection and return. Lean Enterprise Academy Limited is not responsible for paying shipment costs. The Purchaser will be given the option to have the Goods replaced with those ordered (if available) or to be refunded through the payment method used when the Goods were purchased. Refunds and replacements will be issued upon our receipt of the returned



Goods.

- 15.2 If any Goods purchased have faults when they are delivered, the Purchaser should contact Lean Enterprise Academy Limited within 28 working days to arrange collection and return. Lean Enterprise Academy Limited is not responsible for paying shipment costs. Goods must be returned in their original condition with all packaging and documentation. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were purchased.
- 15.3 If Goods are damaged in transit and the damage is apparent on delivery, the Purchaser should sign the delivery note to the effect that the goods have been damaged. In any event, such damage should be reported to Lean Enterprise Academy Limited within 10 working days and arrange collection and return. Lean Enterprise Academy Limited is not responsible for paying shipment costs. Upon receipt of the returned Goods, the price of the Goods, as paid, will be refunded through the payment method used when the Goods were purchased.
- 15.4 If the Goods have been dispatched or have reached you, but the Purchaser decides that they are no longer required, the Goods can be returned to Lean Enterprise Academy Limited within 10 days of receipt. Goods can only be returned for this reason if their packaging remains unopened and the Goods can be re-sold, as new, without any additional work on the part of Lean Enterprise Academy Limited. The Purchaser is responsible for paying shipment costs if Goods are returned for this reason.
- 15.5 If the Purchaser wishes to return Goods to Lean Enterprise Academy Limited for any of the above reasons, please contact us using the details on http://www.leanuk.org/contact-us.aspx to make the appropriate arrangements.
- 15.6 Lean Enterprise Academy Limited reserves the right to exercise discretion with respect to any returns under these Terms and Conditions. Factors which may be taken into account in the exercise of this discretion include, but are not limited to:
  - 15.6.1 Any use or enjoyment that you may have already had out of the Goods;
  - 15.6.2 Any characteristics of the Goods which may cause them to deteriorate or expire rapidly;
  - 15.6.3 The fact that the Goods consist of audio or video recordings or computer software and that the packaging has been opened;
  - 15.6.4 Any discounts that may have formed part of the purchase price of the Goods to reflect any lack of quality made known to the Customer at the time of purchase.

Such discretion to be exercised only within the confines of the law.
